<u>European PPP Expertise Centre 10th Anniversary, Luxembourg, 12 December</u>: François Bergère, Executive Director, LTIIA, moderated the first panel discussion on the future of infrastructure, while Thierry Déau, LTIIA Chairman, moderated the second one on the

future role of the private sector in the delivery of public infrastructure and services.

G20 Nov 30th Leader's summit Buenos Aires communique "Moving forward the G20 Action Plan on the 2030 Agenda for Sustainable Development" explicitely mentions the Infrastructure Data Initiative (IDI) to which 2nd pillar (Private Sector Data) LTIIA contributed, as a member of its steering committee. Further progress and rolling out now expected under Japenese G20 presidency.

LTIIA Workshop on Project Financing in Emerging Countries, London, November 21, 2018: Feedback from participants and members was very supportive of building a deeper dialogue between private sector, MDBs and DFIs to push our recommendations.
